Subject: Regarding medical claim from Insurance Company as well as the State Government.

Sir/ Madam

I have been directed to draw your kind attention towards the subject cited above and state that the Government of Haryana has decided to revise the instructions issued vide No. 2/1028/2012-1HBIII dated 06-02-2013 with regard to medical claims from Insurance Company as under:-

That in case, the State Government beneficiaries, having personal/family health insurance, submit their medical bills for reimbursement from State Government; the medical bills shall be worked out as per existing State Government reimbursement policy. But the worked out amount OR the claimed amount (i.e. over and above the amount paid by the insurance company), **whichever is less**, shall be payable to State Government beneficiary; subject to the condition that the sum of both payable amount by State Government and paid by insurance company shall not exceed the total bill amount.

The details of claim paid by insurance company shall be depicted in the bill issued by the concerned hospital.

This will take effect from the date of issuance and supercede earlier instructions on the subject cited above.
