No. Steno/DHS(D)-RO/2022/10 In exercise of the powers conferred under clause (a) of section 19 of the Pharmacy Act, 1948, the Governor of Haryana, notifies Notice of Election of Six members to the Haryana State Pharmacy Council:

Election of Six members of the Haryana State Pharmacy Council.

Notice is hereby given pursuant to the provisions of Rule 5, of the Rules and Regulations of the Haryana State Pharmacy Council that the election of Six members of the Haryana State Pharmacy Council to serve for the prescribed period; is to be held.

Nominations of eligible persons to fill the six vacancies are invited.

Each candidate must be nominated by a separate nomination paper, but any person entitled to vote at the election, may sign the nomination paper of any number of Candidates not exceeding the number to be elected and for which he is entitled to vote.

Every nomination paper must be in the Form B to Rule 6 (3) giving all the details required therein.

The nomination paper must reach the undersigned not later than **31st day of August, 2022** from whom forms of nomination papers may be obtained on application.


Nomination papers in respect of which provision of Part I of the Rules have not been complied with, or which are not received by the Returning Officer by the aforesaid date will be invalid.

(d)	Declaration of candidates as elected if the number of validly nominated candidates is equal to the number of the notified vacancies (Six)			At 4.00 P.M

(e)	If number of validly nominated candidates are more than 6, then publication of notification of their names & addresses, by the Returning Officer in Official Gazette and on official web site.			At 5.00 PM
(f)	Last date of despatch of voting & other connected papers to begin, if poll is necessary, to each elector by registered/speed pos	Wednesday	07.09.2022	-
(g)	Last date for receipt of voting & other connected papers after poll from electors by registered/speed post.	Saturday	24.09.2022 in the office of Director Health Services (Dental), Haryana, Panchkula.	Up to 5.00 P.M.
(h)	Date of scrutiny and counting of votes/ Result.	Sunday	25.09.2022 in the office of Director Health Services (Dental), Haryana, Panchkula.	9.00 A.M. onwards
