**Subject: Regarding amendments in Medical Reimbursement Policy (w.r.t. Chronic Diseases) for Government employees/Pensioners and their Dependants in State of Haryana.**


In continuation to this office letter no. 2/54/2020-1HB-III, dated 14.07.2020 on the subject cited above.

It is stated that the clause 'vii' of Point No. 1, w.r.t. **Chronic Disease Certificate** is amended as under:

(vii) Reimbursement shall be for entire prescribed medicine(s) **subject to the condition that Civil Surgeon/Medical Superintendent of the concerned District/Institute(s)/College(s)/University should approve the bill on Essentiality Certificate, as the case may be deemed fit (as prescribed by Haryana Government) or refer the patient to the Medical Board, if required.** It is also pointed out that health supplements and other vitamins should not be part of prescription, but if Civil Surgeon/Medical Superintendent approves then allowed all medicine, as the case may be deemed fit.

This issues with the concurrence of the Finance Department conveyed vide their U.O. No. 9652-2FD-II(A)/2021, dated 29.06.2021.
